2.	<p>Lorviqua 25 mg Film-Coated Tablets</p> <p>[Lorlatinib 25 mg]</p> <p>Lorviqua 100 mg Film-Coated Tablets</p> <p>[Lorlatinib 100 mg]</p>	<p><b>INDICATION:</b></p> <p>LORVIQUA as monotherapy is indicated for the treatment of adult patients with anaplastic lymphoma kinase (ALK)-positive advanced non-small cell lung cancer (NSCLC) previously not treated with an ALK inhibitor.</p> <p><b>POSODOLOGY :</b></p> <p>Treatment with lorlatinib should be initiated and supervised by a physician experienced in the use of anticancer medicinal products.</p> <p><u>ALK testing</u></p> <p>Detection of ALK positive NSCLC is necessary for selection of patients for treatment with lorlatinib because these are the only patients for whom benefit has been shown. Assessment for ALK positive NSCLC should be performed by laboratories with demonstrated proficiency in the specific technology being utilized. It is recommended to administer the second dose 28 days after the first dose.</p> <p>There are no data available on the interchangeability of Spikevax with other COVID-19 vaccines to complete the vaccination course. Individuals who have received the first dose of Spikevax should receive the second dose of Spikevax to complete the vaccination course.</p> <p>Paediatric population</p> <p>The safety and efficacy of Spikevax in children and adolescents less than <b>12</b> years of age have not yet been established.
